The Professional Engineers, Architects and Land Surveyors Law found in 22 GCA Chapter 32 include laws concerning examinations, application and registration fees and requirements for registration.

The regulations of the Guam Board of Registration for Professional Engineer, Architects and Land Surveyors are reprinted here in form as exact as possible to those filed with the Legislative Secretary. The substance of the

regulations has not been changed. However, for the purpose of uniformity and ease of use, a new system of numbering has been adopted by the Editor. It is hoped that the revised numerical system will eventually be substituted for Professional Engineers, Architects and Land Surveyors.

§ 1101. Guam Board of Registration for Professional Engineers, Architects and Land Surveyors: Authority.

This Board is constituted in accordance with 22 GCA Chapter 32.

§ 1102. Same: Meetings.

(a) Two (2) regular meetings shall be held each year, one each in January and July.

(b) The Chairman may call additional regular or special meetings when he deems such necessary and shall also call special meetings upon the written request of two (2) members. The members shall be notified by any expedient means at least five (5) days in advance of the purpose, date, time and place of each meeting.

(c) The chairman shall appoint a vice- chairman and a secretary-treasurer at the first regular meeting of the Board after January first each year.

§ 1103. Same: Order of Business.

(a) Regular meetings.

§ 1104. Same: Officers.

(a) Chairman. The Chairman shall be the executive head of the Board and shall preside at all meetings, appoint special committees, cosign all Certificates of Registration issued by the Board and sign all vouchers issued by the Board.

(b) Vice-Chairman. The Vice-Chairman shall perform all duties of the Chairman in case the latter is incapacitated, or absent from the meeting.

(c) Secretary-Treasurer. The Secretary

(1) shall perform such duties as may be assigned by the Chairman,

(2) shall also act as Treasurer of the Board, and as such, shall conduct all financial transactions in accordance with the applicable procedures of the Government of Guam.

§ 1105. Same: Budget.

Prior to October first of each year, the Board shall prepare a budget for the ensuing fiscal year. The budget shall be presented to the Director of Public Works for inclusion in the operating budget of that Department. The secretary shall be authorized to certify all necessary expenditures in accordance with the amount appropriated. The transfer of funds from one item to another, or the over-expenditure of an individual item, shall require the approval of the Board.

§ 1106. Same: Accounting Procedure.

(a) Cash receipt. A receipt shall be issued for all money received by the Board. The Chairman of the Board or his appointed representative shall receive all money paid to the Board and shall issue a consecutively numbered receipt thereof. Such money shall be turned over to the Cashier in the Building Permit Division who shall properly account for all cash received. A field receipt shall be issued by the Cashier in the Building Permit Division to the Chairman of the Board of Engineering the Architectural Examiners. The Chairman of the Board shall appoint a Board Custodian who shall keep appropriate books on behalf of the Board and shall record in the Cash Receipt Book a record of all money received. The Custodian shall close the books at the end of each month and shall submit a

report to the Treasurer for his approval. The Custodian shall be bonded for the amount of not less than \$10,000.

(b) Cash disbursement. All cash disbursements should be supported by invoices or purchase orders, and shall be approved by the Chairman or Treasurer of the Board for payment. All cash disbursements should be recorded in the end of each month and shall submit a report to the Treasurer for his approval.

(c) Monthly report. Monthly financial report shall be prepared as of the last day of the month by the Custodian, appointed by the Chairman, and shall be submitted to the Board not later than the 10th day of the month following. The Public Works Comptroller shall assist the Custodian in the preparation of the monthly financial statement.

§ 1107. Same: Publications of the Board.

The publications of the Board shall be among other things:

(a) A roster of professional engineers, architects, land surveyors, engineers-in-training and roster of corporations, partnerships or associations authorized to practice. These rosters shall be issued biannually with a supplemental roster issued on alternate years.

(b) The complete text of the registration law pertaining to professional engineers, architects, and land surveyors; and rules and by-laws and rules of procedures and rules of professional conduct of the Board to be published biannually or re-issued when required.

(c) The Annual Report of the Board which shall be published annually on August 1. It shall include, among other things, the following:

(1) Dates of examination held.

(2) A summary of the law enforcement activities of the Board.

(3) The audit report for the prior year.

(4) The names, registration numbers, and addresses of all engineers, architects, land surveyors, and engineers-in-training registered since publication of the annual roster.

§ 1108. Same: Amendments of By-Laws.

Proposed amendments to the by-laws may be amended at any regular or special meeting of the Board by no less than a quorum of the Board, provided, however, that such proposed amendments shall have been submitted in writing to the members of the Board at least 30 days prior to the date of the meeting. Amendments to the by-laws should become effective after due process in accordance with the provisions of the Administrative Adjudication Law.

§ 1109. Same: Seals.

The official seal of this Board shall consist of the seal of Guam, surrounded by the words, "Guam Board of Registration for Professional Engineers, Architects, and Land Surveyors." The Board has adopted standard seals for use of registered engineers, architects, and land surveyors similar to those shown below. Seals must make a permanent mark on the document being sealed. These standard seals must be used on all original tracings, blue prints, drawings, specifications, reports, etc., prepared by registered engineers, architects, or land surveyors. [10]

The rules of professional conduct for Professional Engineers, Architects and Land Surveyors are printed here in form as exact as possible to those filed with the Legislative Secretary. The substance of the regulations has not been changed. However, for the purpose of uniformity and ease of use, a new system of numbering has been adopted by the Editor. It is hoped that the revised numerical system will eventually be substituted for that formulated by the Guam Board of Registration for Professional Engineers, Architects and Land Surveyors.

§ 1201. Preamble.

In order to establish and maintain a high standard of integrity, skills and practice in the professions of engineering, architecture and land surveying, to safeguard the life, health, property and welfare of the public and to serve and promote the public interest in the effort to improve human environment, the following Rules of Professional Conduct are promulgated in accordance with 22 GCA Chapter 32, relative to Professional Engineers, Architects and Land Surveyors and shall be binding upon every person holding a certificate of registration as an Engineer, Architect or Land Surveyor and open all partnerships or corporations or other legal entities authorized to offer or perform engineering architecture and land surveying services in Guam.

The Rules of Professional Conduct are herewith promulgated in accordance with those powers vested in the Guam Board of Registration for Professional Engineers, Architects and Land Surveyors by virtue of Public Law 11-218.

All persons registered under 22 GCA Chapter 32, relative to Professional Engineers, Architects and Land Surveyors are charged with having knowledge of the existence of the Rules for Professional Conduct, and shall be deemed to be familiar with their several provisions and to understand them. Such knowledge shall encompass the understanding that the practice of engineering, architecture and land surveying is governed by a statute, as opposed to a right, and the registrant shall be forthright and candid in his statements or written response to the Guam Board of Registration for Professional Engineers, architects and Land Surveyors, Government of Guam, or its representatives on matters pertaining to professional conduct.

§ 1202. Responsibility to the Public.

The architect, engineer and land surveyor shall at all times recognize his primary obligations to protect the safety, health and welfare of the public in the performance of his professional duties.

§ 1203. Competency for Assignments.

(a) The engineer, architect or land surveyor shall undertake to preform assignments only when qualified by registration by the Guam Board and Competency in the specific technical field of engineering, architecture and land surveying.

(b) The engineer, architect or land surveyor, or other certified legal entities may accept an assignment requiring registration outside of their own field of competency, but only to the extent that the major portion of the assignment and their services are restricted to those phases of the projection which they are qualified and competent.

(c) The engineer, architect or land surveyor shall only affix his signature and seal to any engineering, architecture and land surveying plan or document dealing with subject matter for which he has competence by virtue of registration by the Guam Board and to any such plan or document prepared by him or under his direct supervisory control.

(d) In the event a question arises as to the competence of an engineer, architect or land surveyor or other legal entity to perform an engineering, architecture or land surveying assignment in a specific technical field or engineering, architecture and land surveying which cannot be otherwise resolved to the Board's satisfaction, the Board, either upon request of the engineer, architect or land surveyor or by its own volition, may appoint a panel of experts to determine such competency.

§ 1204. Public Statements.

(a) The engineer, architect or land surveyor shall be completely objective and truthful in all professional reports, statements or testimony. He shall not withhold any relevant and pertinent information in such reports, statements or testimony.

(b) The engineer, architect or land surveyor, when serving as an expert or technical witness before any court, commission or other tribunal, shall express an opinion only when it is founded upon adequate knowledge of the facts in issue, upon a background of technical competence in the subject matter, and upon honest conviction of the accuracy and propriety of his testimony.

(c) The engineer, architect or land surveyor shall not attempt to injure, maliciously or falsely, directly or indirectly, the professional reputation,

prospects, practice or employment of another engineer, architect, or land surveyor nor shall he indiscriminately criticize another professional engineer's architect's or land surveyor's work in public. If he believes that another engineer, architect or land surveyor is guilty of unethical or illegal practice, he shall present such information to the Guam Board of Registration for Professional Engineers, Architects and Land Surveyors, Government of Guam, for appropriate action.

§ 1205. Conflict of Interest.

(a) The engineer, architect or land surveyor shall avoid all known conflicts of interest with his employer or client and shall promptly inform his employer or client of any business association, interests, or circumstances which could influence his professional judgment or the quality of his services.

(b) The engineer, architect or land surveyor shall not accept compensation, financial or otherwise, from more than one party for service on the same project, or for services pertaining to the same project, unless the circumstances are fully disclosed to, and agreed to, by all directly involved parties.

(c) The engineer, architect or land surveyor shall not solicit or accept financial or other valuable consideration from material or equipment suppliers for specifying their products.

(d) The engineer, architect or land surveyor shall not solicit or accept gratuities, directly or indirectly, from contractors, their agents or other parties dealing with his client or employer in connection with work for which he is responsible.

(e) When in public service as a member, advisor or employee of a governmental body or department, the engineer, architect or land surveyor shall not participate in consideration or actions with respect to services provided by him or his organization in private engineering, architecture and land surveying practices.

§ 1206. Solicitation of Work.

(a) The engineer, architect or land surveyor shall not offer to pay, either directly or indirectly, any commission, political contribution, gifts, or any other consideration in order to secure work, exclusive of securing salaried positions through employment agencies.

(b) The engineer, architect or land surveyor shall seek professional employment on the basis of qualification and competence for proper accomplishment of the work (and shall charge a professional fee for all professional services rendered). He shall not solicit or submit proposals for professional services on the basis of competitive bidding contrary to law. Competitive bidding is defined as the formal or informal submission or receipt, or verbal or written estimates of costs of proposals in terms of dollars, man days of work required, percentage of construction cost, or any other measure of compensation whereby the prospective client may compare engineering, architecture and land surveying services on a price basis prior to the time that one engineer, architect or land surveyor or one engineering, architecture and land surveying organization, has been selected for negotiations.

(c) The engineer, architect or land surveyor shall not falsify or permit misrepresentation of his, or his associates', academic or professional qualifications. he shall not misrepresent or exaggerate his degree of responsibility in or for the subject matter of prior assignments. Brochures or other presentations incident to the solicitation of employment shall not misrepresent pertinent facts concerning employers, employees, associates, joint-ventures, or his or their past accomplishments with the intent and purpose of enhancing his qualifications and his work.

§ 1207. Advertising.

(a) The engineer, architect and land surveyor shall not advertise his professional services but may utilize the following means of identification:

(1) Business cards. The information displayed must be restricted to name of individual, firm name, address, telephone number, appropriate symbol, name of principal participants and the fields of practice in which the firm is qualified, location map, foreign language translation of the above and professional organization.

(2) Signs on equipment, offices and at the site of projects for which he renders services, limited to firm name, address, telephone number and type of services, as appropriate.

(3) Brochures, letterheads and other factual representations of experience, facilities, personnel and capacity to render service, providing the same are not misleading relative to the extent of

participation in the projects cited, and provided the same are not indiscriminately distributed.

(4) Listings in the classified section of telephone directories, limited to name, address, telephone number and specialties in which the firm is qualified.

(b) The engineer, architect and land surveyor may advertise for recruitment of personnel in appropriate publications or by special distribution. The information presented must be displayed in a dignified manner, restricted to firm name, address, telephone number, appropriate symbol, the fields of practice in which the firm is qualified and factual descriptions of positions available, qualifications required and benefits available.

(c) The engineer, architect and land surveyor may prepare articles for the lay or technical press which are factual, dignified and free from ostentations or laudatory implications. Such articles shall not imply other than his direct participation in the work described unless credit is given to others for their share of the work.

(d) The engineer, architect and land surveyor may extend permission for his name to be used in commercial advertisements, such as may be published by manufacturers, contractors, material suppliers, etc., only by means of a modest dignified notation acknowledging his participation and the scope thereof in the project or product described. Such permission shall not include public endorsement of proprietary products.

(e) The engineer, architect and land surveyor will not allow himself to be listed for employment using exaggerated statements of his qualifications.

§ 1208. Construction Services.

An engineer, architect and land surveyor shall provide construction contract administration when applications are made for building or construction permits involving the public safety and health. The term construction contract administration means making periodic visits to the site by a registered engineer, architect and land surveyor or authorized representative as the case may require, to observe the progress and quality of the executed work and to determine, in general, if the work is proceeding in accordance with the contract documents. It is not required that they make exhaustive or continuous on-site inspections to check the quality or quantity

of the work nor is it intended that the engineer, architect and land surveyor be responsible for construction means, methods, techniques, sequences or procedures, or of safety precautions and programs in connection with the work.

§ 1209. Improper Conduct.

(a) The engineer, architect and land surveyor shall not knowingly associate with, or permit the use of his name or firm name in a business venture by any person or firm which he knows, or has reason to believe, is engaging in business or professional practices of a fraudulent or dishonest nature.

(b) If the engineer, architect or land surveyor or has knowledge or reason to believe that another person or firm may be in violation of any of these provisions or of 22 GCA Chapter 32, relative to Professional Engineers, Architects and Land Surveyors, he shall not withhold any information from the Board of Registration for Professional Engineers, Architects, and Land Surveyors, Government of Guam, and shall cooperate with the Board of Registration for Professional Engineers, Architects and Land Surveyors in furnishing such further information or assistance as may be required by the Board.

§ 1210. Other Jurisdiction.

Conviction of a felony subsequent to registration in the field by any state, territory or possession of the United States, or the revocation or suspension of a professional engineer's architect's or land surveyor's license by another jurisdiction, if for a cause which in Guam would constitute a violation of 5 GCA § 3106, Art. 1 Chapter 3 relative to Professional Engineers, Architects, and Land Surveyors or of these Rules, shall be grounds for a change of violation of these Rules.

The regulations covering applications for registration, examinations, and applications for certification are reprinted here in form as exact as possible to those filed with the Legislative Secretary. The substance of the regulations has not been changed. However, for the purpose of uniformity and ease of use, a new system of numbering has been adopted by the Editor. It is hoped that the revised numerical system will eventually be substituted for that formulated by the Guam Board of Registration for Professional Engineers, Architects and Land Surveyors.

§ 1301. Application for Registration.

Application forms for registration as Professional Engineer, Architect, Land Surveyor, or Engineer-in-Training may be obtained from the Board, care of the Director of Public Works, Department of Public Works, Tumon, Guam. Applications must be neatly written or typed on standard forms approved by the Board.

The names of three or more registered practitioners of the profession in which registration is sought having knowledge of the professional qualifications of the applicant shall be submitted on the application form. All information received from references will be held in strict confidence by the Board. No member of the Board shall be included in the references. An applicant shall not be admitted to the written part of the examination until satisfactory replies have been received from all such references.

§ 1302. Examinations.

(a) General.

(1) The application and experience record as filled out and submitted by an applicant for registration is an important part of the examination. The grade given on the basis of the applicant's experience record is based not only on the duration of the time spent in

professional work on a responsible character, but also on the importance and nature of the work.

(2) Upon receipt of an application and the application fee, the applicant shall be sent a form letter acknowledging the receipt thereof and advising the applicant that the routine of making the necessary investigations will be followed and that he will be notified of whether or not he will be admitted to the examination.

(3) The applicant shall notify the Board of whether or not he will appear for the examination.

(4) An approved applicant shall be given two consecutive opportunities to take the examination. In the event he does not avail himself of these opportunities, his application shall be permanently filed and he will then have the status of a new applicant.

(b) Engineering examinations.

(1) The examination for an Engineer-in-Training and/or examination for registration as a Professional Engineer shall be as prescribed by the National Council of Engineering Examiners. The Board may offer examinations in any of the disciplines offered by the National Council of Engineering Examiners. The Board may offer examinations in any of the disciplines offered by the National Council of Engineering Examiners.

(2) The examination may be waived, with the approval of the Board, for an applicant who:

(A) Has complied with 22 GCA § 32113

(B) Has successfully passed a written examination given by a member board of the National Council of Engineering Examiners and is a registered Professional Engineer in good standing with that member board, and if the requirements of that other Registration Board are not less than the requirements of this Board. Certificates of qualification issued by the National Council of Engineering Examiners may be accepted by the Board as evidence of this requirement.

(3) Each applicant must secure a passing grade of 70 per cent. Grading shall conform to current practices of the National Council of Engineering Examiners.

(c) Architectural Examinations.

(1) The examinations for registration as a Professional Architect shall be as prescribed by the National Council of Architectural Registration Boards.

(2) Grades shall not be averaged. Re-examination will be required for each part of the examination on which a passing grade of 75 percent was not attained.

(3) The examination, with the approval of the Board, may be waived:

(A) If the applicant has successfully passed a written examination given by a member of the National Council of Architectural Registration Boards, is a registered Architect in good standing with that member board and the requirements of that member board are no less than the requirements of this Board; or

(B) If the applicant submits satisfactory evidence he has successfully passed either the Junior or Senior examinations as given by the National Council of Architectural Registration Boards; or

(C) If the applicant has complied with 22 GCA § 32113.

(d) Land Surveyor examinations.

(1) The examination for registration as a Land Surveyor shall be as prescribed by the National Council of Engineering Examiners and, in addition, shall include an examination in Guam Land Matters.

(2) The examination as prescribed by the National Council of Engineering Examiners, with the approval of the Board, may be waived for an applicant who is registered as a Land Surveyor by a duly authorized licensing board of any political subdivision of the United States, provided that the requirements of that board are no less than the requirements of this Board.

(3) An examination in Guam Land Matters is required for all applicants.

(4) Each applicant must secure a passing grade of 70 percent for each part of the examination.

(e) Structural Engineering examinations.

(1) Applicants for the structural engineering examination shall hold registration as a Professional Engineer in the Civil Branch from a state or territory of the United States.

(2) The structural examination shall be as prescribed by the Board, and shall include seismic and other lateral force questions.

(3) Each applicant must secure a passing grade of 70%.

§ 1303. Re-Examination.

Where an applicant has filed all or a part of any required examination, he may, at the discretion of the Board, be given a re-examination of the parts or part in which he failed. re-examination will be given at the next regularly scheduled examination. Applications for re-examination must be received by the Board at least 30 days prior to the examination period, and shall be accompanied by the applicable re-examination fee.
