***MBA position to the board of directors—motion.** It was moved by the California board that the Bylaws Committee be charged to add a member board administrator (MBA) to the board of directors. The MBA shall have served as an MBA for a minimum of two years prior to their appointment. The MBA board member shall be selected by the majority vote of the MBA community at the annual meeting. Idaho seconded the motion. After discussion, the motion failed.

***Designation of Member Board Administrator (MBA) has now been changed to
Member Board Executive (MBE)**

***The NCEES Foundation announced the availability of \$9 million in grants, with the closing date for applications in October 2025.** It was recommended that information be forwarded to the University of Guam School of Engineering.

EBA Gutierrez reported effective August 6th, the PEALS Office is actively progressing with the Certificate of Authorization (FIRMS) renewals. Please note that the submission deadline is October 31, 2025.

The Guam Land Matters Exam has been scheduled for surveyor applicants who have been board approved but have not yet completed the Land Matters Exam, which is a prerequisite for

obtaining a registration license as stipulated in Guam PEALS Law §32113(a)(5)(D)(i)(ii)(E) of Chapter 32 of Title 22 of the Guam Code Annotated. The exam will take place on October 15, 2025, from 8 AM to noon at the Guam Trades Academy classroom. A total of four (4) applicants are expected to attend.

One applicant, Mr. Aaron Blaisdell, PLS, will be unable to attend the Guam Land Matters exam scheduled for October 15th. However, as the NCEES Western Zone Vice President, he will participate in the next NCEES conference.

Our Sec. & Treas, Santos, will oversee the administration of the GLM exam during this event. Sealed results will be collected and forwarded to EBA Gutierrez once the exam is completed.

b. Financial Statement Report

EBA Gutierrez presented the Board's financials, noting revenue tracking for August 2025 at \$275,590; with the PEALS Special Revenue Account; and an ending balance of \$12,903 with the PEALS Bank of Hawaii account for the month of June 2025.

a. CalPac Advertisement for Architect – Update

California Pacific Technical Services, LLC (CalPac) - Architect Ad Investigation:

The board discussed an advertisement by CalPac for an architect position, which has raised concerns as CalPac does not hold a certificate of authorization to offer architectural services. BI Isaac to investigate to clarify CalPac's intentions. This is still under investigation and final review.

b. **PB2025-01 – Complainant:** Michael Pritchard, PE ME1451 **vs.**

Respondent: William B.S.M. Flores, PE CE579

Accusation: Alleged Claim with Documents for Design not Meeting Code Requirement and Life Safety – Update – Case Close

The case pertains to a mechanical engineer and a civil engineer collaborating on the Medical Art Center project. There seems to have been ambiguity regarding the delineation of roles and responsibilities. BI Isaac announced that the PEALS Board has received this matter as a new case. Preliminary investigations suggest that miscommunication occurred among the parties involved. We are awaiting a letter from Mr. Pritchard, PE, to clarify and confirm in writing that the issue has been resolved before the complaint can be officially closed. This letter was received.

The conclusion to this complaint is being drafted for Board Chair's review.

c. Complainant: Fely O. Andrade filed a Complaint on 8/22/2025

Complaint is Against: Celvin Pagcu PE / PEALS COA 433 / Shiellarie's Prime, LLC

Alleged Claim: Service and An Issue, Incident or Violation of Statute, Rules & Regulations

This is an ongoing investigation.

Item 6, Old Business

a. Law, Rules, and Regulations Review

EBA Gutierrez to circulate the latest version of the law, rules and regulations file to all Board members for review. Board members to review and mark up, in red ink, their respective sections of the law, rules and regulations document before the next R&R meeting. EBA Gutierrez to set up a workshop meeting in September for the board to discuss and finalize changes to the law, rules and regulations.

Item 7, Board Discussion

a. Roman Alberto - Application Renewal Status / ME 2229

The State Education Department / The University of the State of New York / Vote and Order Number 34456 / License No. 095364

After thorough consideration and in light of the decision rendered under New York Consent Order Number 34456, the Board has disapproved application for the renewal of registration, but has also agreed not to impose any additional fines. EBA Gutierrez is to issue a letter of Board decision

to both the individual and NCEES Enforcement Exchange Division. A posting will be done for our PEALS Website as well.

It was moved by Sec. & Treas. Santos to suspend Mr. Alberto's Guam engineering license, and agreed to have him reinstate his registration in four years, contingent upon his two-year license suspension and probation, provided he submit proof of completion from New York State. The motion was seconded by BM Cristi and received unanimous approval.

Item 8, Public Comment

a. PNJ Facilities LLC – Renewal and Amendment to Existing COA

The Board addressed a possible conflict of interest concern involving Mr. Perez, PE ME 1074, who serves as the A&E Manager at the Guam Housing & Urban Renewal Authority (GHURA) and is in the process of establishing an LLC for base work alongside another Registered Managing Employee (RME). Board members expressed their concerns regarding the potential conflicts that may arise between his governmental responsibilities and private business endeavors, particularly in light of his role as an RME for mechanical work.

Although a letter from the director indicated that no conflict exists, the Board recognized the possibility of complications arising from this dual engagement, while also acknowledging that perspectives may vary. The discussion concluded with a prior recommendation from Attorney General Keeler, asserting that no conflict would be present if Mr. Perez obtained a letter confirming the absence of conflict.

Additionally, the Board reviewed Mr. Perez's previous business affiliations, including his connections with P&J Facilities and other enterprises, concluding that any future conflicts would be managed through the necessary procurement disclosures. EBA Gutierrez is tasked with circulating Mr. Perez's folder for further review and consideration by the Board.




